

General Contest Rules

1. These Conditions of Entry and Competition Rules apply to the all promotions on the Classic Hits Network. Classic Hits will conduct the promotion. The Radio Network (TRN) reserves the right to add and/or delete participating stations at any time.
2. Entry into the promotion is deemed acceptance of these Conditions of Entry and Competition Rules. TRN reserves the right to exclude any person from the contest on the grounds of criminal record.
3. Multiple entries are acceptable but each must be made as a separate entry – where applicable.
4. The judge's decision will be final and no correspondence will be entered into.
5. Clause to be used only where the prize includes alcohol. The winner must be 18 years of age or over and provide suitable identification (passport or drivers licence) to verify their age before the prize is awarded.
6. Clause to be used only where the prize includes international travel. Where the winner is under 18 years of age they MUST be accompanied by a parent or guardian aged 18 or over.
7. Clause to be used only where the prize includes international travel. The winner MUST have a valid passport and relevant visas. (For travel to or through United States only) It is the winner's responsibility when travelling into or through (transiting included) the United States under the Visa Waiver Program to apply for an Electronic System for Travel Authorisation (ESTA) no later than 72 hours prior to departure. The winner must visit the US Department of Homeland Security website and fill in the required information.
8. Any changes to travel dates or additional accommodation outside the travel period specified made by the winner, which incur additional costs, are to be paid by the prize winner.
9. Incidental costs, such as but not limited to, passport costs, travel insurance, departure taxes, airport transfers and all other personal expenditures will be at the winners expense.
10. TRN disclaims any responsibility for the inability to complete or continue an entry due to equipment malfunction, busy lines, inadvertent disconnection, acts of God or otherwise.
11. Participants are restricted to the use of ordinary telephone equipment.
12. To the extent permitted by law the TRN will not be liable for any loss or damage whatsoever (including but not limited to direct or consequential loss) or for personal injury as a result of the prizes.
13. By participating, all winners grant TRN exclusive permission to use their names, characters, photographs, voices and likeness in connection with promotion of this and other contests and waive any claims to royalty, right or remuneration for such use.
14. All personal details provided to participate in these promotions will be held by TRN for the purpose of this promotion and entries may be used by the TRN for future promotional and marketing purposes, unless otherwise advised by entrants.

15. TRN reserves the right to refuse awarding any prize to a person who is determined to have violated a TRN rule as outlined above, gained unfair advantage in participating in the promotion or obtained a winner status using fraudulent means.

16. No purchase is necessary to win.

17. If entry to this competition is being made on-line (eg) via www.classichits.co.nz, by completing an entry, in addition, the participant agrees to be bound by the website general Terms and Conditions of Use. In the event of conflict between these Competition Terms and Conditions and the website Standard Terms and Conditions of Use, the specific Competition Terms and Conditions will prevail. Rules may be amended from time to time by employees of TRN.

18. TRN reserves the right to discontinue a promotion at any stage.

19. The Promoter is The Radio Network Ltd, 54 Cook Street, Auckland.

20. Winners under the age of 18 must be accompanied by a parent / guardian. Both must sign this agreement and show adequate ID.

21. All prizes must be picked up within 60 days of winning.

22. TRN will not notify the winners of time remaining – it is the sole responsibility of the winner to claim their prize. All unclaimed prizes will be forfeited.

23. In the event a winner chooses not to accept a prize, they forfeit any claims to the prize, which can then be awarded to a runner-up at the discretion of TRN

24. TRN is at liberty to dispose of an unclaimed prize at the end of 60 days.

25. If the specified prize is unavailable due to unforeseen circumstances TRN may substitute another prize of similar or equal value.

26. TRN is not responsible for defective prizes or misuse of a claimed prize.

27. The prizes are not redeemable for cash or transferable. Only the person who originally entered the promotion can be awarded the prize. No other family members, friends, office associates or any other person will be able to participate on another person's behalf.

28. Prizes valued under \$50 may be mailed at the option of TRN; all other prizes must be claimed in person, unless otherwise specified. ID which includes a photo will be required (Examples are drivers license / passport / student card with photo).

29. If in the course of the contest, prior to confirming the winner's identification and address, the phone line drops out or becomes disconnected for any reason, TRN is not responsible for awarding such prize to that caller and will go on to the next available caller.

30. A person is ineligible to enter and / or win a competition if they have won a prize in a Classic Hits competition valued by TRN at more than \$1000 in the 30 days prior to the day they enter the competition.

35. All contest entrants must make themselves available for a photo session if required by TRN and acknowledge TRN has the right use publicity photos in any reasonable manner it sees fit.

36. Winners are responsible for all taxes payable as a result of a prize received or awarded.

37. Special restrictions or qualifications may apply to particular contests, in which case an addendum to these rules will be made. Additional contest rules and/or terms and conditions of a prize or competition on Classic Hits maybe applicable and if so will be posted on the website www.classichits.co.nz or available from reception. The winner's signature in acceptance of these additional terms and conditions will be sought before receipt of the prize.

38. Employees of TRN, any promotion's participating sponsors and their advertising agencies, employees of other radio stations and members of their immediate families are not eligible to participate and win. The term "immediate families" include spouses, Grandparents, Parents, Children, and Grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension.

41. Where voting is required, participants are able to vote as many times as they like, unless otherwise specified.

42. The final decision on all online competitions is that of the promoter (including voting competitions.)

44. Automated voting is not valid. At our suspicion contestants can be disqualified.
